## Rotational Molding Product Design Competition

### Rules and Regulations

#### Participation Eligibility

1. The Competition is open to all current undergraduate students of higher learning in the Industrial Art/Design or Engineering Field of Study.
2. Only one current project can be submitted per school year.

#### Registration

1. Participants must complete the Entry Form and submit entire project (by e-mail) to [rotodesigncomp@winsellinc.com](mailto:rotodesigncomp@winsellinc.com) by May 15<sup>th</sup>, 2020.
2. After the Entry Form is submitted, an e-mail confirmation will be sent to the stated e-mail address.
3. There is no registration fee. Participation is FREE.

#### Submission Requirements

1. **All submissions must use Winsell granite.** Granite color choices can be found on the Winsell Inc. facebook page under the photo album. Granite color choices are not limited to these colors. **Entries will not be accepted if Winsell Granite is not used on the final submission.**
2. All entries must be in English.
3. All entries MUST be submitted in PDF format. No other formats will be accepted. Please save the entry in the following convention: Name of University\_ Last Name\_ First Name\_ Project Title. (Ex. Winsell University\_Shockey\_Fred\_Granite Cooler)
4. All entries must include the Entry Form and summary with the submission. Any entry found to be incomplete will be automatically disqualified from the competition.
5. All entries must fall under the category of “**Outdoor Living Activities**” category, which is defined as: **Enjoying recreation and outdoor life experiences based on wholesome and healthy activities that keep us moving.**

#### Judging

1. The competition will be judged by a panel of former students and professionals in the industry. The judges’ decisions are final and binding. No appeals or additional requests will be entertained.
2. Once winners are determined, they will be notified by an employee at Winsell. Prize money will be sent to the address provided by the participant. Prize money for group projects will be equally divided.

1. Once a design is submitted, Winsell reserves the right to retain any materials for the purpose of publicity, exhibition and website. By entering the competition, designs will be considered public domain and will be subject to potential commercialization of product. Winsell is not held responsible for duplication, reproduction or future use of the product.
2. If a designer contacts Winsell and is interested in more information about a student design, Winsell will give the students name and contact information to the designer.
3. When completing the Entry form, the student grants the organizers unlimited right to use the materials submitted. The use will include the right to reproduce the submitted materials for any purpose the organizers may deem appropriate.
